

A Comparative Review of Non-Islamic Effects on the Islamic Culture and Civilization

The morality, good conduct, prevention from sinful acts, spending a pleasant life, brotherhood, equality, justice in society, simplicity, cleanliness, peace and harmony and basic rights etc have been introduced through the Islamic teachings to the society. The Islamic teachings promote the Islamic culture among the people to identify the best way of life here and hereafter too. Which is not possible without the religion, because there is a great association between religion and culture. Simply we can say that the religion affects all the ways of life that revolve in the society. The concept of haraam (unlawful) and halal (lawful) is not present in the west, consequently the gambling, interest, robbery and illegal sexual intercourse etc, such evil acts are encouraged in the western societies on the name of business. This is the west, in which the immoral ethics are appreciated and people want to spend their lives according to these immoral activities. Which is called the modernism, in the language of the west (7).

4.2. The Culture of Pagan Arabia:

If, we turn the pages of history before the advent of Islam, then many incidences come before us. In the days of ignorance, the pagan Arab spent their lives like animals, they did not know about the civilized life. They considered a woman less than insects. She was deprived of her basic rights, as marital, social, economic and political etc. After the birth of a girl, she was buried alive in the dust (8). A man had several wives more than hundred at a time, whereas, a woman had no right to select a life partner. She was not given any part from inheritance. The ownership of wealth or inheritance was

The murder, inequality, injustice, the trade of interest, riba, illegal sexual intercourse and robbery were common in dark age.They had awful behaviour with slaves.They worshipped idols.They kept three hundred and sixty idols in Khana-e- Kabah (The house of Allah (SWT)).They did not give respect to elders (old age people).Humanity was overwhelmed.The life of a human was not expensive and on a little mistake, a person was killed.The wealth, blood and honour were not saved of anyone, before the dawn of Islam.This was an ignorant society of Arab.On which, the pagan Arab felt proud (10).

4.3.The Islamic Culture and Civilization:

"He said, "One from whose tongue and hands the other Muslims are secure" (14).Therefore the immoral things such as, back bite, dishonesty, insincerity and injustice etc are not allowed in Islam, because these things produce the unbalance environment in society.Allah says in surah Al-Maidah that "Be just; that is nearer to righteousness"(15).It is proved from the mentioned verse that Allah (SWT) likes the act of justice, therefore, He revealed the verse regarding it.One another place it is mentioned in the Holy Quran that "Indeed, Allah orders justice and good conduct"(16).Muhammad (PBUH) advised to Muslims that they live like brothers in society, this proves that brotherhood is one the most important rule of the Islamic culture, without it the creation of peaceful environment will not be possible.The Holy Prophet (PBUH) explained that the blood, honour and wealth of a Muslim is prohibited for another Muslim.It is a duty of every Muslim that he should protect the blood, wealth, life and honour of other Muslims.Because, they all are brothers with each other.Islam is the first religion of this world, which teaches about the rights of humanity, justice and equality, whereas, the concept like that, is not present in other religions.Hadrat Muhammad (PBUH) said in his last sermon fourteen centuries ago that "O people verily, your blood and your property, and your honours are sacrosanct to you until the (Day) you meet your Lord, as sacrosanct as this present day, in this present month, in this present place".He further said "O people! Verily, your wives have a right over you, and you have a right over them".He continued his address and explained "O people! Believers are but brethren.And it is not lawful for a man to take the property of his brother if not with full agreement on his part", moreover, he advised that "O people! Verily, your Lord is One, and your ancestor is also one, all of you are the descendents of Adam, and Adam was made of clay.The most respectable of you in the sight of God is the one who is most fearful of God.No Arab has any excellence over a non-Arab if not by the fear of God".Lastly the Holy Prophet (PBUH) said "O people! Hear and obey even if a Negro with mutilated nose is appointed your commander, this so long as he applies among you the prescriptions of God." "Your slaves, your slaves! Feed them as you eat.Dress them as you put on.If they commit a fault that you don't want to pardon, then sell these slaves of God, but do not torture them"(17).From the above words it proved

that Islam is a peaceful religion and it does not open any kind of door for cruelty and brutality, rather, it teaches the lesson of harmony and peace. When we talk about the society then we cannot ignore the cleanliness. Because, cleanliness is necessary for healthy life, whether it is related to the cleanliness of body, house or society. The simplicity is a sign of faith (Emaan). We can say that both are the basic principles of the Islamic culture. The Quran says that "Allah loves those who turn to Him constantly and He loves those who keep themselves pure and clean"(18). Islam likes the simplicity and cleanliness and advises to Muslims for applying them in every aspect of life. Whether it should be in clothes, eating food, getting marriage, or construction of buildings. In simple words, the simplicity is a soul of Islamic culture, consequently, Islam gives importance to it, because, it plays a vital role to make the environment peaceful and healthy (19).
